

It's been a few years since there has been a regional judging event in Canada, so 2023 was the year to return to the province of Ontario and the city of Mt. Hope. The event was held at the Canadian Warplane Museum which provided a splendid backdrop of aircraft displays from every era of the Canadian Air Force.



The 3-day event included a beautiful collection of Corvettes for judging and sportsman display, including a C8 wrapped in O.P.P. (Ontario Provincial Police) black & white as a recruiting vehicle!





Along with the vast collection of C1's thru C5's, this event featured the first official judging of C6 years 2005-2007. Pete Bergmann heads up the National C6 team and by all accounts, the first judging of C6's went off without any major issues!







If you've not been to this area of Canada before, you must put this on the bucket list as the place to visit. Toronto, the major city in the area, boasts a very diverse melting pot of cultural delights, including the famous Kensington Market area – a collection of great foods from around the world. Doing a foodie tour here is a must! In addition, the area is home to the Niagara wine region with over 50 wineries for your tasting pleasure. Lone Star Regional Event Oct 18-21 2023


The Lone Star Regional is the last Regional Judging Meet of the year and it was held at the Frisco Convention Center adjacent to the Embassy Suites Hotel and Riders Field, the home of the Rough Riders, a Class AA minor league baseball club affiliated with the Texas Rangers.

To give you an idea of the scope of a regional event, about 40-60 cars are registered to be judged across the spectrum of award categories. Typically, there's about 13 cars that are displayed, such as Sportsman, Duntov, Bowtie and others. About 140 folks register, either as judges and/or a car to be judged. Total attendance is usually around 230+. It takes a real team effort to put on a regional, from local chapters to the National team leads and tabulators, vendors and of course, sponsors.



The team in Texas has been putting on the Regional for years, and clearly has mastered the planning and execution of such a large event.

Cars are driven and trailered from across the country, owners bringing their pride and joy for our enjoyment. From C1 thru C8's, the collection of cars on display were meticulously detailed to bring out the best features.



This was my second Regional event where I entered one of my cars for judging – the '96 Grand Sport which I had judged for PV earlier this year at our regional event in Tucson. I trailered the car, about a 2,000 round-trip mile journey and about \$1200 in diesel fuel and DEF for my GMC 2500 HD!



Tom Barr's C4 team of judges did an outstanding job going thru the car and pointing out opportunities for improvements of which I'm very grateful to receive! Total point deduction was 49, which puts the car in position for a Dave Hill Award. While my car was being judged, I had the opportunity to judge Interior on Pete Bergmann's C6 team.

I was fortunate to receive a Top Flight for the 1996 Grand Sport, a very satisfying goal accomplished!




AGM Nov 2023 Webmaster Report
